Section B-Terms & Conditions for the use of an Electric Pool Bicycle

1. Users are responsible for ensuring the electric bicycle remains in good condition throughout the duration of the hire period.
2. Users are responsible for reporting to CET any incidents/accidents that occur whilst in charge of an electric pool bicycle.
3. If, during the hire period, the electric bicycle is not locked (with the chain lock provided) to a suitably fixed/immovable object (i.e. a dedicated cycle parking rack) and is subsequently stolen, or equipment is lost whilst in use, the user will be liable for the cost of any replacement.
4. The user/rider undertakes to ride the bicycle with due care and attention, in compliance with the Highway Code (re.: <https://highwaycodeuk.co.uk>), and in a law-abiding manner that takes into consideration the conditions of the road and traffic as well as other users of the roads and highways.
5. The CET staff have the right to refuse the use of an electric pool bicycle at any time if they believe a staff member is not capable of using it safely.
6. It is the users responsibility to familiarise themselves with the electric bicycle before riding (instruction cards are included in the pannier pack).
7. It is the responsibility of the user to use the electric pool bicycle for the purpose for which it is intended – including ensuring that the electric bicycle is not overloaded.
8. It will be at the user’s choice if they wish to wear their own cycle helmet or other safety/personal protective equipment items when using the electric bicycle
9. The user or rider of the electric bicycle does so entirely at their own risk and accepts that they are wholly responsible for their actions and their time while using the electric bicycle.

Section C- Declaration of User/Rider:

By signing this declaration, I agree to the following:

1. I understand that during the hire/borrowing period (between collection and return to Longstanton Park & Ride) that the hired/borrowed electric bicycle and all associated equipment are my responsibility and I ride it entirely at my own risk.
2. I agree to stop using the Electric Bicycle and inform the Scheme Operators immediately of any changes to my circumstances that may affect my ability to use the Electric Bicycle.
3. I agree to stop using the electric bicycle and inform the Scheme Operators (Cambridge Electric Transport) immediately of any changes to the electric bicycle that I believe might endanger myself, other road/traffic users and/or any other party.
4. I consider myself to be competent and able to use an electric pool bicycle for the purposes of business travel to and from Longstanton Park & Ride.
5. I have inspected the electric bike, lock and any other accessories and been given instructions and I confirm I understood said instructions and I am willing and able to comply with the given verbal and written instructions.
6. I understand and agree to all the Terms & Conditions in Section B of this form.
